The Run coordinator, in consultation with the spokesperson, will appoint for each TOTEM run 1 or 2 shift leader(s), who will operate with the same level of responsibility defined for the coordinators.

# PHYSICS & PUBLICATIONS

The analysis and physics results are discussed and blessed in the joint Physics/Analysis Meetings as regulated in [ref. TOTEM Organization Sheets (approved by the Collaboration Board in 2011)].

The publication process is managed by the Editorial Board according to its mandate [ref. TOTEM Governance] and defined practices [ref. EB Publication Policy].

## **Editorial Board membership:**

Chairperson: M.G.Catanesi

Members *ex-officio*: Spokesperson, or Deputy-Spokesperson, Physics Coordinator, Technical Coordinator

Composition: K.Eggert, M.Bozzo, T.Csorgo, M.Deile, V.Avati, M.G.Catanesi

The editorial process is based on peers-to-peers assessments and on a consensus-based mechanism (the time frame to achieve consensus is defined by the Editorial Board chair).

For each paper, the Editorial Board chair, in consultation with the spokesperson, appoints writer(s) and referee(s), who should produce a version of the complete paper by consensus. In case of no consensus between them, the spokesperson decides (if the spokesperson has been involved in the writing or in the refereeing, then the Editorial Board chair decides).

The complete paper version is released to the collaboration for comments according to [ref. EB Publication Policy]. The comments from the collaboration should be sent to the Editorial Board and they are evaluated/implemented by the writer(s) and the referee(s) by consensus to produce the final paper. In case of no consensus between them or with any member of the Editorial Board on the final version, the Editorial Board chair will request a majority vote decision of the Collaboration Board.

The Editorial Board chairperson is responsible to perform the preprints and papers submission to the journals (he/she can delegate this task to the Latex editors defined below).

The Editorial Board includes dedicated panels assigned to specific activities:

- Conference management and speaker bureau – managers: M.Deile, K.Eggert, V.Avati
- Latex – editors: M.Bozzo, M.Deile,... – archives: T.Csorgo
- WWW – webmaster: V.Avati

# FUTURE PROGRAMME

The TOTEM future programme consists of the future physics programme (including also a common physics programme with CMS) and the detector upgrade programme (including also collaboration with CMS and R&D projects).

Two working groups are defined with the mandates and composition described below:

- The TOTEM Future Physics working group
- The TOTEM Detector Upgrade working group.

The two groups operate within the responsibility framework of the spokesperson on scientific and executive grounds, and they report to the Collaboration Board for all matters concerning the relations to CMS.
